

Green Room Collective Season Agreement

Tuition Breakdown:

1 class	\$100/month
2 classes	\$150/month
3 classes	\$200/month
4 classes	\$250/month
Unlimited	\$300/month
Combo Class	\$125/month per class

*Siblings will receive 10% off the standard tuition rate

You will be able to set up auto draft through our website for ease of use. We also accept cash and check in studio.

A discount of 10% is offered for tuition payments paid in full at the time of registration for the full year.

Payments

Tuition is based on ten monthly payments September thru June and is due on the first of each month. Studio closures are calculated into the tuition fee.

Payments received after the 10th of the month will incur a \$15.00 late fee for each day past due. All tuition payments are non-refundable.

There will be a \$30.00 charge for returned checks, and NFS or ACH on debit/credit cards.

Registration Fee

\$50.00 per dancer. Registration fees are due at registration and are non-refundable.

Costume Fee

Costume fees are \$95.00 per dancer per dance. This fee includes the costume, accessories, and one pair of tights (if needed). This fee does NOT include shoes. All costume fees are nonrefundable. If a dancer drops out of a piece and a costume has already been ordered, you are still responsible to pay for that costume in full. Accounts must be up to date to receive costumes.

***Costume fees are due January 15th, 2025**

Showcase Fee

\$150.00 per dancer. The showcase fee ensures theatre rental and associated costs, Season T-shirt, and Green Room Collective end of year party. Showcase fees are non-refundable.

Showcase fees are due February 15th.

Private Lessons

Private Lessons for dance, piano, and vocal are available at \$75/hour or \$45/half hour.

Photo Release
